

Abengoa, S.A. ("**Abengoa**" or the "**Company**"), pursuant to article 228 of the Restated Securities Market Act approved by Royal Legislative Decree 4/2015, of 23 October (el Texto Refundido de la Ley del Mercado de Valores, aprobado por el Real Decreto Legislativo 4/2015, de 23 de octubre), informs the Spanish Securities Market Commission (Comisión Nacional del Mercado de Valores) of the following:

Relevant Fact

In connection with the issue by Abengoa of convertible/exchangeable bonds for an amount of 400,000,000€ at 6.25% and due on 2019 (ISIN XS0875275819) traded in the multilateral negotiation system EuroMTF of Luxembourg (the "**Bonds**"), Abengoa announces the registration in the Commercial Registry of Seville on 26 July 2016 of the corresponding share capital increase for a total of 204,081 new Class B shares of the Company of two thousand euro (0.0002€) of face value each (the "**Shares**"), issued as a consequence of the conversion of Bonds for a total amount 600,000 euros. The share capital Abengoa has been increased for a total amount of 40.82 euros, being the final share capital of Abengoa after the share capital increase of 1,838,779.95 euros.

Likewise, the Company announces that the Shares have been admitted to trading on the Stock Exchanges of Madrid and Barcelona, through the interconnection system (*Mercado Continuo*), on the date hereof with effects as of 11 August 2016.
