

Abengoa recognized again as world leader for action on climate change by CDP

- Abengoa has been recognized in the Climate Disclosure Project (CDP) Supplier A List of companies implementing policies to battle climate change.

February 1st, 2016. - Abengoa (MCE: ABG.B/P SM /NASDAQ: ABGB), the international company that applies innovative technology solutions for sustainability in the energy and environment sectors, has been recognized by CDP (Climate Disclosure Project) for the implementation of actions to fight climate change.

The index is included in the new report by CDP "From Agreement to Action". The document is designed to mobilize suppliers toward a climate resilient world in light of the recent global climate change agreement from COP21, the summit taking place late last year. Specifically, the A List presents 71 suppliers identified as demonstrating a "superior approach to climate change mitigation". Companies included in the index represent less than 2 % of companies from around the world participating and evaluated by CDP. Additionally, among the 71 companies in recognized, 19 of them are classified as "industrials", including Abengoa.

The A List is part of the new report by CDP "From Agreement to Action". The document has been designed to mobilize suppliers toward a climate resilient world in the light of the recent global climate change agreement from COP21 in Paris late last year. The study has been produced at the request of 75 multinational purchasers who work with the aforementioned non-governmental organization to better understand and communication of implemented policies by companies managing business risks and opportunities derived from climate change.
